### Covid-19 Restrictions: ACT

Following the recent outbreaks of Covid-19 in the Greater Sydney area, the ACT Government has imposed restrictions for ACT residents.

**Masks** are now mandatory in Places of Worship and most other indoor premises across the ACT. They are also required whilst on and waiting for all forms of public transport. These restrictions came into effect from midnight 27 June 2021 with no expiry at this stage. For full details, please visit the ACT Government site:

**Stay at home and travel restrictions** have also been applied:

- If you have been in the **Greater Sydney Area** (including Blue Mountains, Central Coast and Wollongong regions) on or after 21 June 2021, you are required to complete an online declaration and remain in your home until 11:59pm 9 July 2021. You may leave your home for essential purposes only.
- If you have been in the **Northern Territory** within the LGA's of City of Darwin, City of Palmerston and Litchfield you are required to complete an online declaration and remain in your home until 1:30pm 29 June 2021. You may leave your home for essential purposes only.

The above restrictions are in addition to existing ones, including:

- Any venue can have up to 25 people across the venue
- If you have more than 25 people, you must follow the 1 person per 2 square metre rule
- A Covid Safety Plan must be in place if you have more than 25 people attending
- All businesses (including Places of Worship) are required to register for and use the Check IN CBR app

No other restrictions have been imposed at this stage, however, we recommend that morning teas and the service of food cease at this stage bearing in mind the mandatory wearing of masks.
