### Extension of Covid-19 Restrictions

#### Greater Sydney Area

##### Local Government Areas of concern

Three more Local Government Areas (LGA's) have added to the restricted LGA's within the Greater Sydney Area bringing the total to 8. The LGA's of concern are Blacktown, Campbelltown, Canterbury-Bankstown, Cumberland, Fairfield, Georges River, Liverpool and Parramatta.

These 8 LGA's have additional restrictions over and above those of the Greater Sydney Area.

For these LGA's, strict stay at home rules apply and travel outside your LGA is not allowed. If you cannot work from home, and you need to leave your LGA for work, you may only do so if you are classed as an authorised worker:

Recent changes to this list now include:

- Faith leaders broadcasting services and ceremonies at places of worship, or providing end of life care and support

This means that if you need to travel out of your LGA to your place of worship to provide livestreaming or the recording of a service, you are now able to do so. If you live in the Canterbury-Bankstown LGA and travel outside your LGA, you must get tested every 3 days.

##### The rest of the Greater Sydney Area

**Stay at home rules apply.** You may only leave home if you have a reasonable excuse:

- Obtain food and essential services
- Attend work if you cannot work from home
- For education if it is not possible to do it at home
- Exercise outdoors within your LGA or within 10kms of your home
- Medical or caring reasons

# COVID-19

## GUIDANCE NOTE

- To provide pastoral care if you are a priest, minister of religion or a member of a religious order
- Other reasonable excuses such as emergencies

**Face masks** are to be carried with you whenever you leave home and are to be worn in any indoor non-residential premises. Wear a mask any time you cannot stay 1.5m away from people you don't live with.

**Places of Worship** remain closed except for livestreaming or recording of services (max 5 people).

**Livestreaming or recording** of a service is permissible but people involved must be kept to an absolute minimum, especially in LGA's of concern. We are recommending no more than 4-5 people only. Up to 2 singers are allowed during recording, provided there are no more than 2 others in the recording space, and they are wearing masks. The singers are not required to wear masks while they are singing but must be 3 metres from anyone else.

**Weddings** are not allowed in the Greater Sydney area.

**Funerals** may be held with up to a maximum of 10 people attending. Those essential to the running of the funeral are not included in the 10. This is at the discretion of the Church Council concerned.

**Outdoor gatherings** are limited to a maximum of 2 people.

### Regional and Rural NSW

**Places of Worship** may remain open subject to the maximum number of 1 person per 4 square metres (or 25 people, whichever is the greater). There still must be a Covid-19 Safety Plan in place and complied with.

**Singing** is not allowed by congregants indoors. Up to 5 people may sing from the front but they must wear masks, be 1.5m from each other and 3m from the congregation.

**Masks** are to be worn by those over 12 years old in all non-residential premises, including Places of Worship and workplaces.

# COVID-19

## GUIDANCE NOTE

**Weddings** are allowed with numbers up to the maximum allowed under the 4 square metre rule. Dancing is only permitted by the bridal party up to a maximum of 20.

**Funerals** are allowed with numbers up to the maximum allowed under the 4 square metre rule

**Outdoor gatherings** are permitted up to 200 people.

**Visitors to homes** are allowed up to a maximum of 5 at any one time.
