

Supervision List 2022

In the Uniting Church in Australia, the goal of supervision is understood as the continuing enhancement of ministry in a context of trust and openness by means of a relationship of mutual accountability that focuses on actual ministry experiences.

The Supervisors listed in this document have been recommended by UCA ministers in placement in the Synod of NSW/ACT. The information about each supervisor has been provided by the Supervisors themselves and all have agreed to be included. Ministers and leaders who are looking for supervision need to contact a potential Supervisor directly for more information and to negotiate an initial meeting.

I can do phone supervision, but it is not my preferred mode.</p>	<p>Supervision is a multifaceted activity incorporating review and guidance; practice management and reflection; stimulation, challenge and education. I essentially come from two key framework backgrounds:</p> <p>Transformative Learning, which is centred in the idea that making sense or meaning of our experiences requires critical evaluation of old and new learnings. I like to think of it as, 'Considering our learnings of yesterday in light of what we have learned today.'</p> <p>Seven-eyed Model of Supervision, which acknowledges that effective supervision must be able to shift its focus in order to notice what is happening for the supervisee, and ultimately their client, by deliberately looking through different lenses. It is a process model of supervision that holds that learning is chiefly facilitated through understanding what is happening both in the supervision environment, and in the relationships between client, practitioner and supervisor.</p> <p>I am a believer in objectively determining the efficacy of supervision. The willingness to stay 'ignorant' until the story reveals what needs to be known is another important element.
